 Replacement corner of Harbor View Rd and Mikel Drive across the Street from the Presbyterian Church.
 JIPSD is in schematic design with the Architects Caplea Coe Architects, Inc. (CCA). At the end of
 Schematic Design, the architects will have a final set of drawing that JDavis Construction Construction
 Manager At Risk can provide the guaranteed maximum price. At the same time, we're going through
 the permitting process and hope to obtain the green light for ground disturbance by late Summer 2024.
 The construction process is slated to take 14 months so we're looking at late 2025 to have the new Fire
 Station #2 operational; and that's an aggressive time frame. JIPSD intends to make the exterior of Station
 #2 look very similar to Station #1 1108 Folly Rd. The JIPSD ladder truck is 14 years old and well past is
 useful Life. JIPSD ordered the replacement ladder truck in January of 2022 we are on pace to get the
 new ladder truck in April 2024. The ladder truck is the work-horse of the JIPSD Fire Department and you'll
 see it rolling up and down Folly Road just like the current ladder truck. Joe Marcinkus, JIPSD Director of
 Wastewater Services, spoke about the ongoing wastewater infrastructure projects updates.
