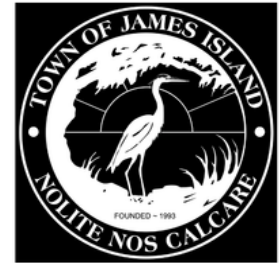

Mill Point Park

The Town of James Island is proud and excited to announce the purchase of a 6.6 acre property located on Mill Point Rd. This property will be utilized as a passive public park. This beautiful property features a broad array of azalea bushes and camellia trees, marsh front views, a small house that has historical ties to the South Carolina Agricultural Society and a spacious oak grove. The Town plans to maintain the park in approximately its current form.



New Arts & Cultural Center

Due to issues with the building and access to parking, the previous location of the Arts & Cultural Center on Camp Rd. has been closed. Fortunately, the Town has a very exciting opportunity with the construction and opening of a new Arts & Cultural Center on a Town-owned 1 acre lot at the corner of Dills Bluff Rd. and Hillman St. A public meeting was held for community members to give their thoughts and provide input. Many of the participants completed a survey provided by the Town to help steer the new direction of the services and programming. Mayor Brook Lyon is hopeful the new facility will open in 2026.

Stormwater Improvements & AmeriCorp Volunteers



We've been busy!

Over the past year we have made great strides working to resolve stormwater and flooding issues in the Town. Several drainage projects have been completed including ones in the Quail Run, Oceanview, Woodhaven, Centerville and Lynwood neighborhoods. The Town has completed these with the help of American Rescue Plan Act funding and utilizing our Stormwater Bank Fund with Charleston County. Our amazing stormwater team works closely with the County, SCDOT and private contractors to help us accomplish these improvements. Cleaning ditches and culverts throughout the Town and responding to drainage requests promptly is a top priority for us. These efforts will be ongoing. We have also enjoyed having the assistance of AmeriCorps volunteers, who have been helping us complete some of these projects since early November and will continue to help us until the end of February.

In addition, to try and help mitigate flooding, the Town offers free sandbags (10 bags per household) at Town Hall during flooding and rain events. Town staff and volunteers, utilizing our new "sandbagger" were able to provide and fill over 17,000 bags to help residents prepare for Hurricane Debby this fall.

Tree Protections, Removals and Pruning

Any tree eighteen inches (18") or greater in diameter at 4.5'ft above the grade (Diameter at Breast Height, or DBH), excluding pine trees and sweet gums, are considered grand trees. DBH can be found by taking the circumference of the tree and dividing that number by 3.14.

On single-family residential lots, only grand trees require permits for removal. On lots that are zoned differently, requirements vary depending on certain conditions such as the health of the trees, location, proposed development, amount of trees existing on the site, etc. Generally speaking, trees that are 8" in diameter or greater are considered protected on commercially-zoned lots.

James Island's tree protection ordinances are in place to protect existing trees, including the Town's extraordinary grand oaks. Trees provide a number of great benefits. The protection and preservation of trees promotes the enhanced health, safety and general welfare of our Town.
